**Terms of reference**

- (a) To make recommendations from time to time in regard to changes which may in its opinion be advisable in the Act, Rules and Regulations and forms and procedures to be followed in the running of the Scheme.
- (b) To decide within the broad framework of the general decisions and programme of priorities of the Board, the following matters, provided that where the specific approval of the Board or the appropriate government is required, such approval shall be taken:
  - (i) Extension of the scheme to other categories of establishments in accordance with the order of priorities laid down by the Board;
  - (ii) Extension of scheme to new areas and extension of medical care to families;
  - (iii) Adoption of special measures to meet peculiar conditions in the area;
  - (iv) Improvement in benefits;
  - (v) Provision of indoor medical treatment;

- (vi) Measures and arrangements for the rehabilitation of insured persons in the area, who are permanently disabled;
- (vii) Securing compliance by employers with the various provisions of the Employees' State Insurance Act, the Regulations and other rules and instructions;
- (c) To review from time to time the working of the Scheme in the State both on the medical side as well as cash benefit side and to advise the Board and State Government on measures to improve the working of the Scheme both in regard to payment of cash benefits and administration of medical benefits and in particular to promote preventive health measures, safety and personal hygiene.
- (d) To look into general grievances, complaints and difficulties of insured persons, employers etc. as it may consider necessary;
